



## FEES AND PAYMENTS

### TUITION FEES INFORMATION FOR THE ACADEMIC YEAR 2024-25

<b>APPLICATION FEE</b>	5,000 BAHT	(non-refundable)
<b>ADMISSIONS FEE / RESERVATION FEE*</b>	220,000 BAHT	(non-refundable)
<b>ACCEPTANCE DEPOSIT**</b>	150,000 BAHT	(refundable, less any outstanding payment)

\*The reservation fee is for any student who books a place in advance or on the school's waiting list. When a place is available and the student has passed the admissions assessment, this fee is transferred and will act as the admissions fee.

If a place is not available within 12 months of being placed on the waiting list, the reservation fee will be refunded in full, or parents can request to remain on the waiting list and the reservation fee will be refunded at a later date if a place is not available.

\*\*The conditions for refund are as follows:

- upon the student's graduation (completion of year 13) from the school or
- when the withdrawal notice is received at least one full term's notice before the child leaves (a withdrawal notice form is available at the Parent Liaison) or
- when the school requires the applicant's departure for reasons other than disciplinary.

### INCLUDED IN THE TUITION FEES:

Lunch, morning and afternoon snacks, after school activities (free ASAs), clubs and societies, special education needs (within school policy), books.

### NOT INCLUDED IN THE TUITION FEES:

English as an Additional Language (EAL), school uniform, sports kit, personal equipment, individual music tuition, external examinations, compulsory residential trips, school trips, school bus transportation, after school activities (paid ASAs), additional special education needs support (outside the basic support provided by the school), school photographs, military service training for Y11-13.

### ANNUAL PAYMENT DISCOUNT

A 2% discount is available if the full 2024-25 academic year's fees are paid by Term 1 due date.

### SIBLING DISCOUNT

There is a 5% sibling discount for a second child and a 10% sibling discount for 3rd child or more child attending the school at the same time.

### METHODS OF PAYMENT:

- **By Credit Card** presented at the DBS Finance Office. A Credit Card Fee of 1-3% will be payable by the parent in addition to the invoiced Tuition and Fees.
- **By Citibank / UOB Credit Card:** No credit card fees charged for invoices paid in full on or before 31st March 2025.
- **By Cheque:** Payable to Denla British International School, as named Payee. The school will accept cheques from any third party paying on behalf of the parent and student, but it remains the parents' responsibility to ensure school fees are paid before each term's due date. Post-dated cheques will not be accepted.

### LATE AND OVERDUE PAYMENTS

Simple interest will be charged on a day-to-day basis on Tuition Fees which are unpaid. The rate of interest charged will be at 1.25% per month accruing on a daily basis. The parents shall also be liable to pay all costs, fees, disbursements and charges including legal fees and costs reasonably incurred by the school in the recovery of any unpaid Tuition Fees regardless of the value of the school's claim.
